- TO HELP AVOID ERRORS IN THE CATALOG Please typewrite or print clearly all information on your entry form. Include your zip code in your mailing address. Send the signature page of the entry form. Entries cannot be accepted without a signature.
- NO REFUND FOR DUPLICATE ENTRIES. Every effort to find all duplicate entries will be made; however, if the entry has been processed, no refund will be made.
- UNSIGNED ENTRIES CANNOT BE ACCEPTED. Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry form are NOT ACCEPTABLE. Acknowledgement of entries will be made as soon as practical. Judging program and numbers will be emailed to the exhibitors. Should such acknowledgement not be received by the exhibitor within a reasonable time, please notify the Trial Secretary.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE. Entry fees shall not be refunded for the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If, because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snowstorms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance, and, in the event, it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
- POST DATED CHECKS or RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will add a
  collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may
  result in their being put on a CASH ONLY basis.
- **DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

### INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- 3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

### AGREEMENT
